#### AWF FINANCIAL SUMMARY 2003-2012

This document summarizes the donations received by AwF and AwF (UK) and the expenditure on projects and expenses from the inception of the charity in 2003 until 31 May 2012<sup>1</sup>.

In the period 2003 to 31 May 2012 AwF and AwF (UK) have received US\$ 181,318 in donations. Total expenses were US\$ 19,849. Funds utilized for field projects to date totaled US\$ 100,005.

In addition, AwF and AwF (UK) have been allotted US\$ 174,132 for joint activities with other organizations.

Total income raised by AwF and AwF (UK) have therefore reached over US\$ 355,000 and the funds used in our project work to date have been almost US\$ 275,000.

Currently (31 May 2012), approximately US\$ 61,000 remains available to cover current project commitments and to fund new projects.
